## Treasurer's Report:

## Highway Access Report:

Regular on-going meetings have taken place with Government officials to move this project to next levels. Further meetings are scheduled over the next 2-3 weeks.

# Park Progress:

Alf Jablonski reported results of recent POSAC meeting, where agreement was reached to utilize the "reserve" fund, if required, to complete Phase 1 of Meadowood Community Park. Alf will check into feasibility of a Handicapped Trail in the forested area of Trails for future development in Phase 2 or 3.

## **Special Events:**

Elaine Peligren reported that the Park should be sufficiently completed enough to have an "Official Opening" during our Canada Day celebration.

Decisions on our Grant applicatons are anticipated later in April, while the Federal Grant application results should be known at the end of May.

## **Neighbourhood Emergency Preparedness:**

Annie Donald reported an Emergency Action Plan, amended & approved at the last C.M.R.A. meeting, has been posted to the C.M.R.A. website. We are sending a letter of request to L.Q.R.V. Strata Council to post this to their website, along with the Strategic Wildfire document which this Action Plan refers to throughout the document. The first 4 pages are being laminated for posting at Meadowood Store and LQRV Mailbox Bulletin Boards. A Neighbourhood Emergency Organizational meeting was held on March 8<sup>th</sup> with only 4 attendees. Two more residents have come forward to assist with organizing PODS within their immediate neighbourhood. This is a start and will need to be expanded to include all residences in our area. To organize POD groups within the Corcan-Meadowood area, we would ideally need approximately 40 POD leaders. Each leader would have roughly 15 residences in their group of homes. The whole concept is to ensure everyone's safety and well-being throughout an emergency Event.
