Gerry left a message for Joe Stanhope, to discuss letter from Paul Thorkelsson of the RDN stating that the Official Community Plan does not need revision to allow highway access to the Corcan Meadowood area. No discussion is needed. Below is an excerpt from the October letter.

Please note, that this letter does not constitute the Regional District of Nanaimo's support for the Corcan Road interchange proposal. A formal letter of support may be requested from the Regional Board by making a request to the Board at one of its regularly scheduled meetings. The Board may or may not support such a request.

Where do we go from here? Next step is to find a way to fund the highway, given that the Ministry of Transportation has expressed interest in partnerships but does not have money set aside for our highway access. We need to put our referendum on the RDN ballot in November to find out if residents are prepared to help fund the highway access. To do this, voters need to know exactly what it costs to travel from home with or without the access. Would travel costs saved exceed extra taxes incurred? According to Ozzie, who has done a lot of research already, travel costs would be halved with highway access.

Dave wants to do thorough research into costs, based on type of vehicle, exact length of popular routes, cost of gas, maintenance and depreciation. Commercial vehicle calculations need to be done. With this information, each resident can create a personal scenario and make individual calculations. We will use our bank balance to fund a mail out with this information. All sources for information will be cited. This research needs to be done quickly so we can get info out by March, and then start moving forward with the November 2011 referendum. **Dave to action.** 

Scott Fraser will be contacted so he knows we are planning to take a tax increase to referendum (term and amount to be negotiated with MOT) to find out if we can enter a funding partnership with the Ministry of Transportation. **Elaine to action.** 

Gerry has heard that the federal infrastructure incentive program is back (this is the program that helped fund the roundabout in Qualicum Town) He and Rob will contact Dr. James Lunney to find out how to apply for funding. **Rob and Gerry to action.**

We need to know how much our access would cost. Gerry will discuss this with Dave Edgar. Gerry to action.
