Julian Fell briefed us on talks with the RDN regarding our community park. We have significant government support, due the letters written by residents and preparation done by our POSAC (Parks and Open Spaces Commitee) members. With a \$5000.00 commitment from our association, we will receive priority for funding. \$100,000.00 has been applied for to be spent over several years. A consultant has been hired to draw up a plan for our park.

We are hoping to obtain provincial cooperation for highway access through Partnership BC. Partnerships British Columbia is a company responsible for bringing together ministries, agencies and the private sector to develop projects through public-private partnerships. As a company registered under the Business Corporations Act, Partnerships BC is wholly owned by the Province of British Columbia and reports to its shareholder the Minister of Finance.

Julian is actively promoting the needs of our area in his new role as Area F Director.

Annie Donald reported on our very successful Halloween celebration. We obtained a \$1500 grant from the Regional District to hold our fireworks display.in 2011. 200 people attended with a 2 week prep. period. Way to go, team. This year, we will aim for more lighting and make other improvements.

Lighthouse Community Hall is the home of our big meetings. To support upkeep there, donation of 120.00 to be made to advertise CMRA on Lighthouse website. Dave motioned. Gerry approved. Annie seconded.

Julian passed out schedule for Parks development. We pay taxes of \$90-100k yearly, so what is our result? The Regional District decision to buy Moorecroft set us back. There is no parks budget by electoral area, so Julian is tracking our money to see where it is spent. Reg Nosworthy is also working on this.

Elaine has contacted Scott Fraser, MLA about the condition of our roads. Emcon Services Inc.1-866-353-3136, holds the maintenance contract for our area. We are encouraged to write letters of complaint for the Transportation Manager, Kirsten

This government session has just opened so Scott Fraser will draft a letter to the Minister to post on our website. Scott will request a meeting with Mr. Lekstrom to discuss our needs. In February our area experienced strong winds sending power lines down and stranding residents in and out of our area until BC Hydro could fix. Discussion ensued. Our highway emergency exit is open if one has the key. Fire trucks need permission to use the private road given liability issues. Scott Fraser would like letters from residents affected, as this kind of problem is part of our need for highway access. Letters will be submitted to the Ministry of Transport.
