Meeting called to order at 6:30 p.m.

<u>Treasurers' Report:</u> In the absence of Diane Anderson (Treasurer), Elaine Peligren provided the following updates:

Fundraising Sucesses from April 6<sup>th</sup> Open House: Food Concession, Bottle Drive & Penny Drive - \$1,138.20

Bank balances: Operating Account \$5,961.32

Highway Access Account \$9,450.04 Plus additional funds committed - \$2,000.

## **New Business:**

- A. Community Pavilion Emergency Gathering Place & R.D.N. Support
  Gerry Anderson reported new information received from a meeting with R.D.N. that our community should have an emergency meeting &/or gathering place which logistically could be located near the Meadowood Fire Hall area.

  Ideally the Meadowood Community Park would be a key central location where we would need a Community Hall properly equipped for emergencies. Once we have our formal Business Plan completed, we can proceed with applications for further grants or funding opportunities which may be available for our Community Pavilion project. A meeting is to be arranged with R.D.N. personnel in May to ascertain further details and requirements.
- B. Emergency Regional District Protocol: Investigations into Emergency Preparedness and Evacuation procedures for our area revealed the following protocol which would be followed in the event of a serious emergency. When an Emergency is identified, the R.D.N. (Government) would invoke the Emergency Measures Act and be responsible to inform all the stakeholders (Responders). Actions would vary, depending on the situation. Perhaps an emergency could entail having to "stay in place" for an extended period of several days or much longer, until roads could be cleared/repaired. Alternatively, an immediate evacuation may be necessary due to wildfire. R.C.M.P. are tasked with evacuation notification (doorto-door, etc.). A local Community Centre could be an Evacuation Centre, free of immediate dangers hence the need for a Meadowood Community Park Pavilion. Meadowood Fire Hall is not equipped or designated as a Refuge Centre. This information ties in with our efforts to establish a Neighbourhood Emergency Preparedness Program.
- C. Open House & Emergency Preparedness Plans JUNE 15<sup>th</sup>, 2013

  Mid June has been identified as an ideal time to hold another Open House to promote the Highway Access project.

  This could be coordinated with an opportunity to provide an additional information session on how our community can best prepare for potential emergencies within individual neighbourhoods. Motion made by Elaine Ivancic,

  Seconded by Ozzie Jimmo to do a postal mail out brochure advertising both events for June 15<sup>th</sup> .... Carried.
- D. Thank You cards have been delivered to the generous contributors and supporters of our April 6<sup>th</sup> Open House on the Highway Access Interchange.
- E. Official Logo & Business Cards:

As business dealings for our Residents' Association are escalating, it is deemed appropriate to have proper letterhead and business cards for our Directors. Moved by Bob Donald that we proceed with utilizing present design for letterhead and have generic business cards printed, Seconded by Tim Peligren, Carried.

## **Old Business:**

A. (1) Interchange Information Meeting held April 6<sup>th</sup>, 2013

Great response, dialogue and interaction took place with residents on Highway Access proposals. The Food Concession, Bottle Drive & Penny Drive were a tremendous success, as outlined in the Treasurers' report. A further Open House planned in June should generate even greater action on this front.

(2) Letter to new Provincial Minister of Transportation

Moved by Gerry Anderson, Seconded by Tim Peligren, that a letter be sent after May 14<sup>th</sup>, 2013 to the new Minister of Transportation about progress on our Fundraising Program for Highway Access project, to request any and all available financial assistance towards our initiative. – Carried.
