We will be in touch with MLA Fraser when he returns from Ottawa where he has been representing the Province of British Columbia on another important matter. At that time, arrangements can be finalized for meetings going forward.

Park Progress & Community Centre:

Alf Jablonski reported that a response has been received from the Regional District of Nanaimo, Parks & Recreation, giving an update on progress of the Meadowood Community Hall process. The R.D.N. is presently working on:

- a) Conducting a traffic impact study for the proposed project, to satisfy road access items required by MoTI;
- b) Updating the park's concept plan to incorporate the new parkland addition and proposed building site;
- c) Commissioning a Quantity Survey for the proposed building to get updated construction costs for the 2018/2019 market.

A more detailed update will be provided after their review of findings next month.

<u>Special Events (Halloween):</u> Elaine Peligren advised the amount of \$2,313.00 has been received from the Regional District of Nanaimo, Recreational Grant to be utilized for our Halloween Event later this year.

Neighbourhood Emergency Preparedness: Emergency Preparedness plans are under way to revitalize the Neighbourhood overall plans through meetings, awareness programs and exercises.
