  - background on RDN purchase of land from the school board for the development of a community centre and the association involvement with developing a plan for usage budget and business plan to operate the centre
  - once hall is started association needs to put together an hall operating committee
  - Questions about budget \$950,000. is it enough? Also playground equipment for park
  - Chris explained: unique set-up that facility will be funded by RDN; ACRA puts on activities that we pay into but not have in our area; report will come back on Oct. 25; in 5<sup>th</sup> year we

Specifically, the Association may lease and license real property for the purposes of providing a community centre on behalf of the Regional District, and may operate a community centre service."

  - MOTI bg on how slowly they work to make changes on things
  - bridge updating regulations for park use bylaw to allow ATVs across bridge and into the park;
     will be an emergency access as well; we can't use it all the time is because is it goes through private land; tender s going out for this
  - report is going to RDN for community centre; funding is coming from Community Works Fund
  - talk about incorporating Area F
  - we get approx. 300K/year from the gas tax we can ask for things
    - Questions: concern over secondary access and the 1 hour window to remove concrete barrier at the old highway emergency access – suggestion we should draft up a letter the residents can email to minister
    - Leanne suggests people write to Claire Trevena, Minister of MOTC and Scott Fraser MLA
    - don't give up keep up the pressure by residents demanding action
    - questions about how to get things done like a play park or trails so children do not have to walk on the road
  - 10) New Business
    - a) General discussion on funds in Highway Account

Moved by Ramona Jones: CMRA will contact the original people and ask if they want to have the highway access fund returned to them. Amendment to the Motion: Moved by Loraine Harris: ask the original people who donated to the fund and offer them the option of the association to retain the funds for the emergency access gate. Motion as amended approved.

Ramona Jones has offered to contact the people who originally donated to the fund Motion: That the money is not accounted for from the receipts for the original highway access fund be used immediately to fund emergency access options.
